### Cloud-Connected Archiving

The Barracuda Message Archiver can move or copy archives to the cloud. Setting the archiving policy to "mirror" mode replicates all data to the Barracuda Cloud for disaster recovery purposes. Setting the policy to "Rotate" mode allows the appliance to scale-up and use the Barracuda Cloud as a secondary tier of storage.



### Simplify Email Management

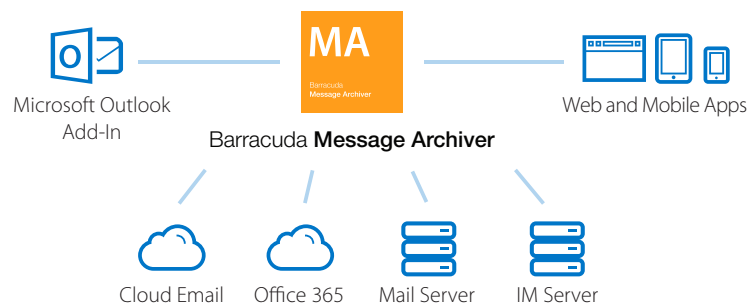
Users treat mailboxes as filing cabinets, driving expensive server storage to expand continually. They respond to storage limits by archiving messages locally with PSTs, which are not managed (or even seen) by IT. The Barracuda Message Archiver dramatically reduces demand for email server storage through attachment stubbing, message/attachment deduplication, and compression, while also eliminating the need for PSTs.



### Streamline eDiscovery and Compliance

The Barracuda Message Archiver's indexed archive supports extensive search, auditing/permissions, legal hold, and export helping facilitate eDiscovery and retention. An intuitive interface and powerful feature set shortens response time to ensure messages are found easily when needed. Federated search lets users search across appliances and cloud-based data even when email services are unavailable.
